children's educational outcomes in various jurisdictions have good models

A: Children's educational outcomes are reviewed, systematically at each stage of a child's care; at each placement change; and whenever a placement change occurs. A number of states, including New York, Oregon, and Pennsylvania, have rules or statutes that require courts to conduct inquiries, findings, and orders regarding educational outcomes.

For example, Judicial Rule 2011 require juvenile courts to review and issue appropriate orders regarding educational outcomes at each stage of the judicial process, from initial hearing to the permanency hearing. Courts track various issues: a child's educational progress, whether school placement is appropriate, and whether the child has a decisionmaker.

Q: What judicial tools or checks are available?

Through the "Education Court Report," Hamilton County Children's Services has committed to help support the education of children in Cincinnati Public Schools. The "Education Court Report" is a supplement to the court report and is provided to the student's case worker. The report provides detailed information regarding the child's needs, performance, and placement.
